



## **Gamma Resources Announces Engagement of Momentum IR Corp. for Investor Relations Services and Option Grant**

Vancouver, BC, July 15, 2025 – GAMMA RESOURCES LTD. (TSX.V:GAMA, FSE:6GC, OTC:MLLOF) ("**Gamma**" or the "**Company**") is pleased to announce that it has engaged Momentum IR Corp. ("**Momentum**") a Toronto based investor relations and corporate communications firm led by Nisha Hasan, to provide investor relations and advisory services.

Gamma's President and Chief Executive Officer Gabriel Alonso-Mendoza, stated:

Under the terms of the agreement, Gamma granted 50,000 stock options to Momentum at an exercise price of \$0.11 exercisable for a period of 5 years and 450,000 stock options at a later date as determined by the Company, exercisable at the price per common share at the date of grant for a period of 5 years, in accordance with the Company's Stock Option Plan. The options will vest in four equal tranches over the course of twelve months from the date of the grant. The agreement is subject to the approval of the TSX Venture Exchange.

In addition, the Company granted 50,000 stock options to a consultant at an exercise price of \$0.11 exercisable for a period of 5 years.
